

Privacy Policy

The contents hereof shall constitute Fitkids Education and Training Pvt Ltd (“Fitkids”) privacy policy in relation to the Service on the Website (“Privacy Policy”). All references to ‘our’, ‘us’ or ‘we’ within this Privacy Policy are deemed to refer to Fitkids and all its associated programmes and products. Fitkids does not send Spam or sell email addresses. This Privacy Policy describes how we treat the information we collect when you visit our website(s) (individually and collectively “Website”) and/or request any services from Fitkids.

Please note that this Privacy Policy is only applicable to the users of the Website and the information and data gathered on the Website and not to any other information or website. You are hereby advised to read this Privacy Policy carefully and fully understand the nature and purpose of gathering and/or collecting sensitive, personal and other information and the usage, disclosure and sharing of such information. By viewing or accessing the Website or by requesting any services through the Website, you hereby also consent to Fitkids sharing information with third party service providers engaged by Fitkids in relation to its operations and to the transfer and/or store Personal Information and data across borders.

Terms not defined herein will have the meaning ascribed to them in Fitkids’ Terms of Service for the Website, as available at Terms of Service. This Privacy Policy is incorporated into, and part of, the Terms of Service which govern the Website.

YOUR PERSONAL INFORMATION COLLECTED BY FITKIDS

In general, you can visit our Website without revealing your identity or any Personal Information about yourself. However, you may not be able to access certain areas or services that require registration or need you to reveal your identity and/or other information about you. Information that we collect from you will vary depending upon the activity you seek to engage in and may include your name, age, email address, place of residence and phone number (“Personal Information”). For example, in case you request us to provide you with updates on Fitkids or its programmes, in order to send you an e-mail for the same we will need, and will collect, your e-mail address. Fitkids will not sell, rent or share your Personal Information, including your e-mail address, with any third parties for marketing purposes without your express permission. Fitkids may share your Personal Information in accordance with this Privacy Policy and/or of the purpose of complying with applicable law. Though we make every effort to preserve user privacy, Fitkids may need to disclose Personal Information when required by law and when we have a good faith belief that such action is necessary to comply with a current judicial proceeding, a court order or legal process that Fitkids receives. We may also collect demographic and other data, which may include Personally Information, generally through surveys and forms which you may or may not choose to participate in. If you place an order for goods or services through Fitkids, you may be required to provide your shipping address and/or other contact information. For the purpose of payments in relation to your orders, you shall be directed to a third party payment gateway for this purpose. Please make yourself aware of the terms of service and privacy policy implemented by such third party payment gateway service provider prior to providing any of your credit card information and other financial information or any other personal information. We are not responsible for your use of such third party payment gateway service provider, and do not endorse the services or policies of such third party service provider or

provide any guarantee that they will adhere to the same privacy and security practices as we do. You must not provide us with your Personal Information if you are not at least 18 years of age as of the date you provide the information. We do not intend to collect Personal Information from any person below the age of 18 years. If we receive notice or believe that someone under this age has provided us with Personal Information we will make every reasonable effort to remove such Personal Information from our files or flag such Personal Information and retain it for the sole purpose of ensuring that it is not used any further.

USAGE INFORMATION

In addition to collecting personal and non-personal information, Fitkids may also collect non-personal, aggregated information about subscribers' use of our Website. This information is not personally identifiable and will only be used to find out how subscribers use our service and Website. For example, this information will tell us how much time users spend on our Website, from which other sites subscribers came, and to what other sites subscribers go. The collection of this information allows us to, among other things, prepare for traffic load demands and to efficiently deliver relevant information.

To the extent that you do provide us with Personal Information, we wish to maintain accurate and current Personal Information. Where we collect Personal Information from you on our Website, should you need to update or correct that Personal Information, please contact us and we will make reasonable efforts to incorporate the changes in your Personal Information that we hold as soon as practicable. Upon your request, you can access a summary of the information we collect about you. You will have an opportunity to correct, update or modify this information.

CHOICE/OPT-OUT

If we ever send you information by e-mail concerning new products or services that you did not expressly request, we will provide you with an e-mail address or link by which you may request no future notices.

TRACKING

Like most websites, Fitkids may make use of browser "cookies." Cookies are strings of text and numbers that can identify your computer to us when you visit our Website. They allow us to see if you have logged in, check your status as a member, and facilitate access to your preferences. Fitkids will not use cookies to retrieve information from a computer that is unrelated to our Website or services. Fitkids may also use transparent GIF images. We would use these images to track the e-mails that we send out.

IP ADDRESS

When you visit our Website, we log standard information such as your IP address, which is a number that can be used to identify your location and Internet Service Provider, along with the URL from which you came to our Website and the URLs visited on our Website. A URL is the full address of a website page, which may or may not contain some Personally Identifiable Information about the person who is viewing it. When we send messages to you or others, we may provide a URL link to the Fitkids Website that contains an alphanumeric

identifier, which allows us to identify the person to whom we sent the message so that we can personalize our content for that individual.

THIRD PARTY COOKIES

In the course of serving advertisements to this Website, our third-party advertisers may place or recognize a unique cookie on your browser.

THIRD PARTY ADVERTISING

Some of the ads appearing on our Website may be delivered by one of our advertising partners. Information about your visit to their websites, such as number of times you have viewed an ad (but not your name, address, or other personal information), may be used to serve ads to you.

BUSINESS TRANSITIONS

In the event Fitkids goes through a change of ownership or control, such as a merger, acquisition by another company, or sale of a portion of its assets, users' personal information will, in most instances, be part of the assets transferred, and you expressly consent to any such transfer.

All information described above is stored on restricted database servers controlled by us. We follow generally accepted industry standards to protect the Personal Information submitted to us, both during transmission and, once we receive it, for storage and disposal. When you enter sensitive information on our registration or order forms, we encrypt that information using secure socket layer technology (SSL). The databases are stored on servers secured behind a firewall; access to the servers is password-protected and is strictly limited. No method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, while we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security. Fitkids addresses any discrepancies and grievances of all users of this Website with respect to processing of information in a time bound manner.

If you choose to provide us with your Personal Information, we may transfer that Personal Information from your country or jurisdiction to other countries or jurisdictions around the world. Your Personal Information may be collected and stored on servers located in the territory of India and such other countries as may be required.
